Susan Wall, Cheryl-Ann Bolouk, and John Sytek all ran unopposed, retaining their positions of Town Clerk, Tax Collector, and Treasurer, respectively.

Steven Goddu and Thomas Plante were elected to the Budget Committee, Bev Donovan and Bob Gibbs won the Planning Board race, and Bernard Campbell and Jeffrey Hatch were elected to the Zoning Board of Adjustment.

Coffee with a Cop

The idea behind Coffee with a Cop was first sparked during a 2011 brainstorming session of the Hawthorne, California Police Department. It was a simple proposal to break through barriers and build community through a cup of coffee. Since that time, Coffee with a Cop events have been held in all 50 U.S. states, as well as interna-



tionally. The key to Coffee with a Cop's growing success is that it opens the door for interactions outside of the crisis situations that typically bring law enforcement officers and community members together.

Salem Police Department's Community Service Unit has adopted the practice and has now held three Coffee with a Cop events at McDonald's and Mary Anne's. This is a great opportunity to meet with the Chief, Deputy Chief, Captains and Community Service Unit to ask questions, voice concerns, and just chat about things going on in Salem. As of right now, an event is being planned each quarter, with the next one being held either the end of April or beginning of May. Stay tuned for more updates!



SFD Offers Valued-Added Programs

The Salem Fire Department is pleased to offer two value-added programs to our residents. The first is our Community CPR program, held once or twice a month, usually at Central Fire Station on Main Street. This is a Heart-Saver program that teaches Adult, Child, Infant and CPR, as well as Automatic External Defibrillation, Heimlich maneuver, and we discuss Naloxone administration for opioid overdoses. The class is generally about 2 hours in length, and costs \$15 (for the card).

The second program is a child safety seat inspection appointment. Trained SFD members will inspect residents' car safety seats to ensure they are installed to the manufacturer's recommendations. This program is offered by appointment only, and takes approximately 30 minutes per seat. Installation instructions will be reviewed with the parents by the SFD members.

- The Finance Department is hard at work processing payroll, paying vendor invoices, answering utility billing questions, ensuring departmental purchases comply with the town's purchasing and procurement policy, and providing support for other departments in town.

Garabedian Drive Economic Revitalization Zone

Salem's Community Development department has recently submitted an application for the Garabedian Drive Economic Revitalization Zone (ERZ). The ERZ will provide opportunities for the development of vacant land and expansion of underutilized buildings and sites. The proposed ERZ area is shown on the below map and the proposed zone will be located in the Commercial/Industrial C Zoning District.

Included in the proposed ERZ area is the 32-acre former Waste Water Treatment Facility parcel located on SARL Drive (143-9475) and north end of Garabedian Drive, offers an incredible opportunity for the redevelopment of a highly underutilized property. This project has the potential to spur the revitalization of the entire ERZ area. Road improvements as a part of this project may provide a needed link between Garabedian Drive and Route 28 (South Broadway), greatly increasing connectivity and access and creating additional opportunities for growth. In addition, the Salem Bike-Ped Corridor runs along the eastern border of the proposed ERZ, bringing foot and bicycle traffic and of-

fers future area workers recreational opportunities.


This ERZ area represents over 130 acres split into 17 lots with total property values of nearly \$30 million. The average property value of the parcels is \$1,706,888. In addition to the former Waste Water Treatment Facility site, there are five vacant lots located in the zone which offer opportunities for development. The existing buildings are not all occupied to their full capacity, offering even more opportunities for business expansion.

For a business to qualify for an ERZ tax credit, it must create a least one (1) new job in the state and meet the following criteria:

- The business must be physically located in an approved ERZ;
- Investment in plant or equipment must be made directly by the business applying for the ERZ tax credit;
- Jobs created must be full time, direct employees, and not be contracted or 'temp' jobs;
- The investment and the job creation must take place within one calendar year

The maximum amount of tax credit is \$240,000 per application, and the maximum applied per year by a taxpayer is limited to \$40,000.

Salem will be notified by April if the zone has been approved by the Commissioner of the Department of Resources and Economic Development.



The proposed ERZ will encompass 17 lots in the area of Garabedian Drive and the site of the former Waste Water Treatment Facility.

New Pumper Under Construction

Construction of the new pumper at Pierce Manufacturing in Appleton, Wisconsin is well underway. The funding for this pumper was appropriated at the 2016 Town Meeting. As you can see by the pictures, these trucks are literally built by hand from the frame up. In these pictures you can see the galvanized frame rails and stainless steel fuel tank and straps. These were specified to combat the effects of liquid calcium chloride and rock salt on our apparatus. We expect this apparatus will be completed sometime in late April. When it is commissioned in service it will be assigned to Engine Company 1 out of Central Station on Main Street.

Salem Bike-Ped Corridor

Many Salem residents and visitors have been enjoying use of the first phase of the Salem Bike-Ped Corridor since its completion in October, 2016. Some new safety features in the intersections of Route 28 and Range Road and Route 28 and Old Rockingham Road will be coming soon this spring.

Phase II will pick up where the first phase left off at Old Rockingham Road and will continue approximately 3,000 feet to Willow Street where it will connect with the section already completed in the area of Tuscan Market. The Town has been working with CMA

Engineers on the Feasibility Study phase of the project. After Phase II is complete, Salem will have approximately 1.8 miles of paved trail. Future projects will continue south along the corridor to the border.


ENGINEERING DIVISION

Now that Town Elections are complete, the Engineering Division is finalizing award of construction contracts for the 2017 Road Program. This year's program includes construction on Haverhill Road, Klein Drive, Parker Circle, Commercial Drive, Woodland Avenue, Bradford Drive, Hampstead Road, Brookdale Road, Salem Street, Clare Lane, Equestrian Road, Off Marie Avenue, Sullivan Court, First Street, Leeside Drive, Marie Avenue, Marianna Road, and Stanley Brook Drive. Given the favorable construction bids received this year, we plan to add a few additional roads to the 2017 program. We thank the residents of Salem for your continued support of this important program.



Engineering continues to provide permitting for construction activities and technical review of projects before the Planning and Zoning Boards, the largest being the Tuscan Village project. In addition staff continues with engineering oversight of the former wastewater treatment plant demolition and major water and sewer improvements on South Broadway.

PUBLIC WORKS DIVISION



March certainly has come in like a lion. After mild temperatures in the month of February winter came roaring back with a large snowstorm dropping 16" of heavy wet snow on March 14th—15th. Staff set up voting booths for the rescheduled Town election on Saturday and removed political signs in the right of way the following week. Extensive snow clearing has been ongoing over the past week to open up sidewalks and push back snowbanks where visibility is an issue. Routine maintenance has increased of late for mailbox repairs and pothole patching while staff keeps up with the fleet working on cutting edges and calcium systems. Streets Section personnel continue to support the Fleet Section with both maintenance and repair of vehicles and equipment. There were two burials performed at Pine Grove Cemetery. Planning and coordination has started for the upcoming paving and construction season including review of the mill and overlay work.

UTILITIES DIVISION

The floors at the Canobie Lake raw water pump house were scraped and coated with new epoxy to better facilitate cleaning up splash and debris when removing the screens for cleaning. Along with daily plant operations the clarifiers and filters were washed to remove alum and floc buildup. Town water continues to be served by Arlington Pond with an average of 1.7 million gallons per day during the winter months. The Sewer Master Plan has been finalized and drafted with review by staff before final presentation in April. A training meeting was held for the work order system - Veworks as part of the water asset management grant. Day to day operations have been busy in regards to digsafes and pre-construction meetings for the upcoming season including the redevelopment of Rockingham Park. The Exit 2 Water Project - Commercial Drive booster station and Manor Parkway rehabilitation is nearing completion with the installation of the pumps with start up and testing to be performed next month.
