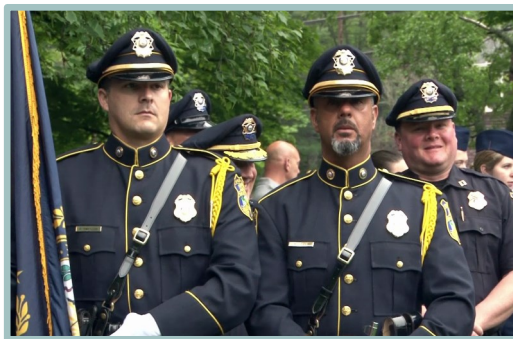

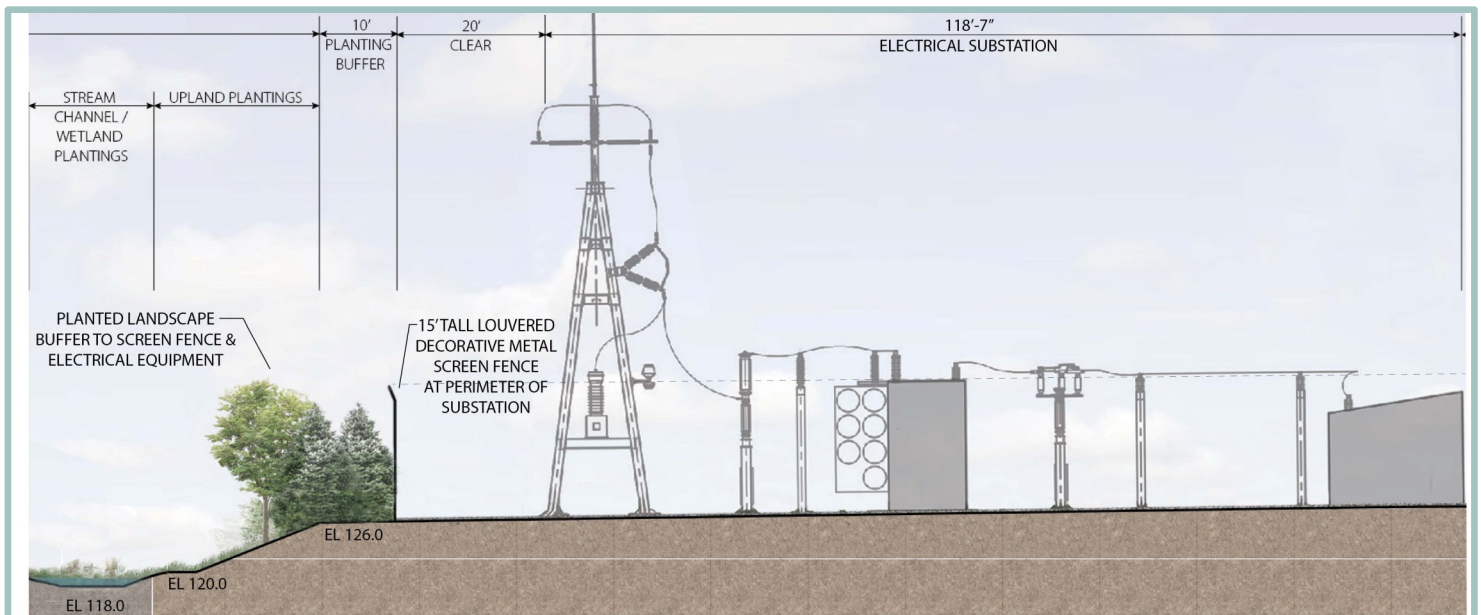

Finance

- In the last issue of Town Hall Times we reviewed some reasons why U.S. state and local governments do not follow the same accounting and reporting standards that commercial entities do. In this issue we are providing two additional reasons why they differ. First is that commercial entities use budgets as benchmarks for performance, as a tool for planning, or a goal for growth. Whereas, governments are legally bound to the budget. A significant part of the accountability for management of public resources is the budget. Second, is the difference in interest of a stockholder vs. a taxpayer. Stockholders are generally focused on the profit generated by the commercial entity. Taxpayers are interested in the government's ability to deliver services and meet future obligations.

- The Finance Department is hard at work processing payroll, paying vendor invoices, answering utility billing questions, ensuring departmental purchases comply with the town's purchasing and procurement policy, and providing support to all departments in town.

Engineering

It's been a busy spring construction season with crack sealing, drainage work on Main Street, and roadway reconstruction work on Garabedian Drive and Zion Hill Road. Main St drainage work will be completed in the next few weeks. Garabedian Dr has been base paved and will receive a top coat soon. Zion Hill Rd construction started at the north end, with base paving complete north of the North Salem Elementary School. Work on Zion Hill Rd south of the school will continue throughout the summer. Construction activity will be ramping up as we kick off our mill and overlay program and begin water and sewer construction on South Broadway.

Work on South Broadway will begin south of Cluff Crossing Rd (near Target) and will proceed from south to north, extending to Main Street. It's a two-year project, with challenging construction due to deep sewer mains, so work will proceed slowly. Lane closures are necessary, so expect delays and seek alternate routes if possible. A "Neighborhood Construction Meeting" was held on May 30th, which included a project overview and question and answer session. The meeting was recorded and can be viewed [here](#).

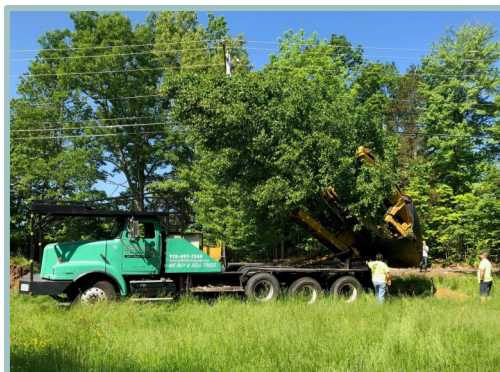

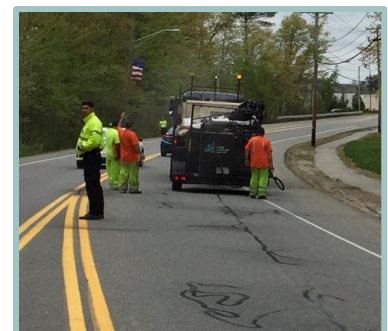

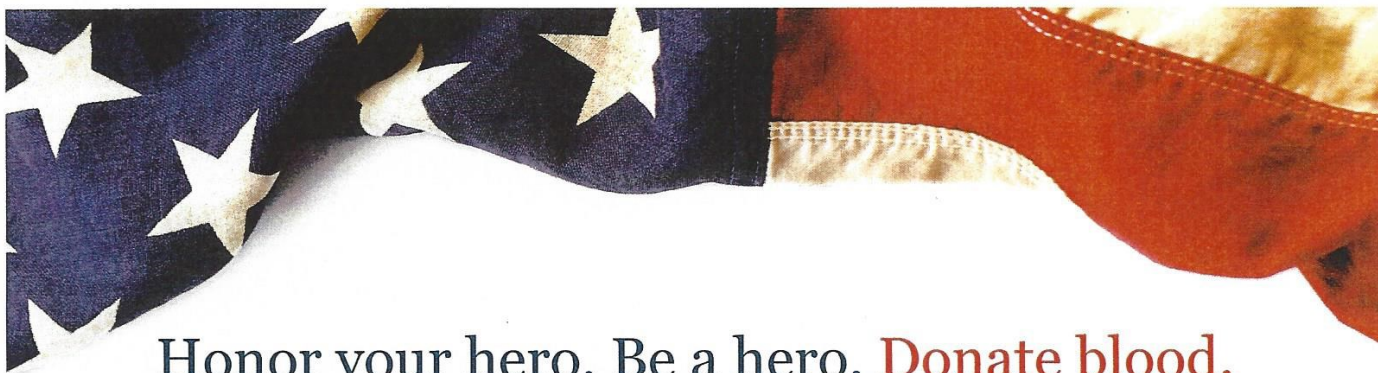

PRESS RELEASE

The Town of Salem, New Hampshire mailed the first installment of the 2018 Property Tax bill on May 29, 2018. The bill is due on or before July 2, 2018, or there will be a 12% per annum interest charge. The total dollar amount due should be approximately one-half (½) of last year's total taxes for the year except those properties which are new construction or the assessed value has changed.

The bill will come in a first class envelope which includes a return envelope for the taxpayer's convenience. By using this return envelope, the tax payment will be sent directly to the Town of Salem's bank for processing. The remittance stub from the bill must be included with the check. If you wish to receive a stamped paid receipt please mail the entire bill with your payment and include a self-addressed envelope. We encourage you to mail your property tax payment in the return envelope provided or directly to the Tax Collector at the Town Hall. If you choose to pay the bill in person, we urge you to come in to the Town offices before the final due date of the bill.

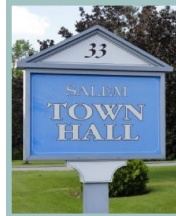
