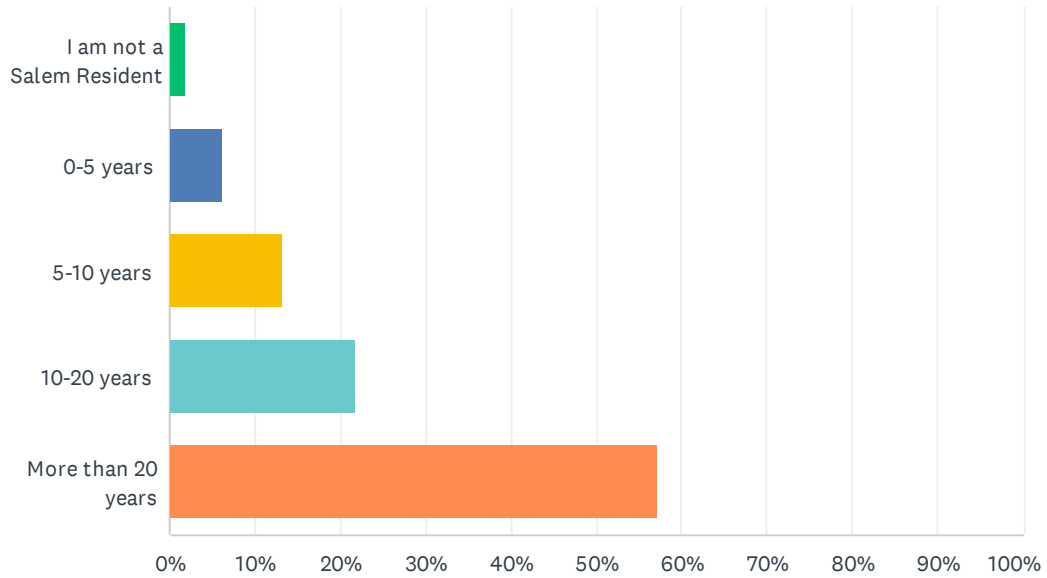


Q1 How long have you been a Salem resident?

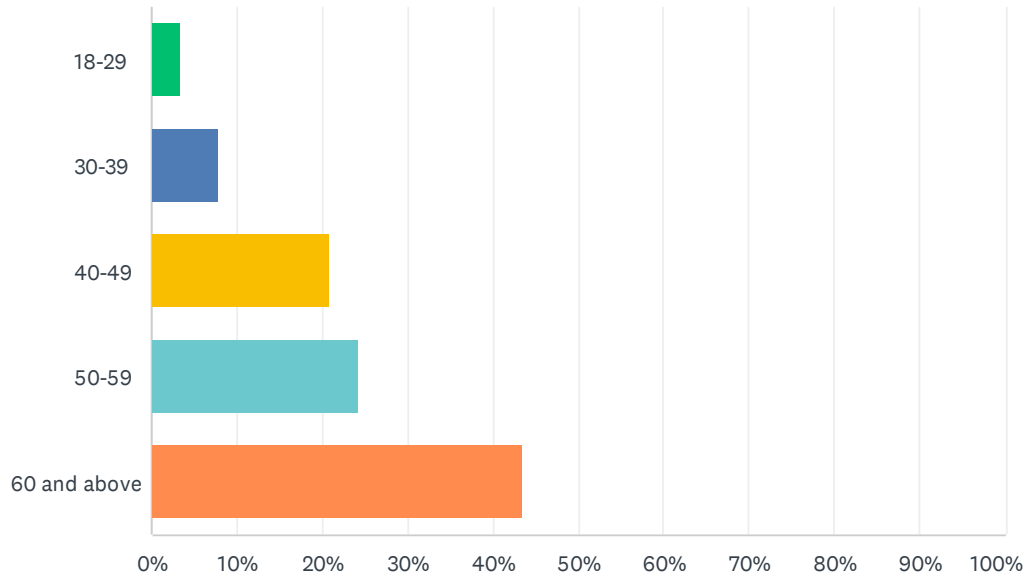

Q2 What is you age bracket?

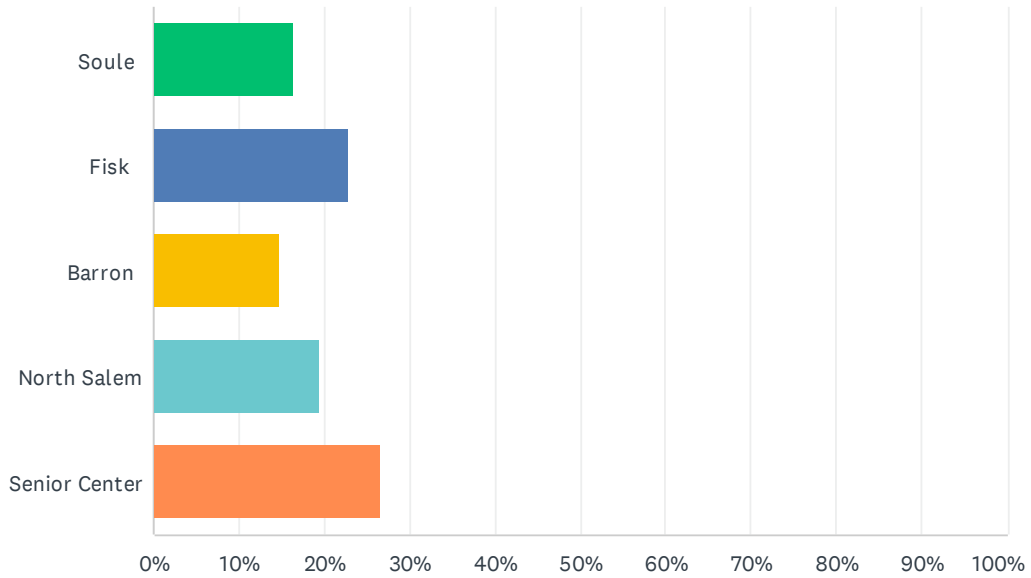

Q3 Which polling place do you vote at?

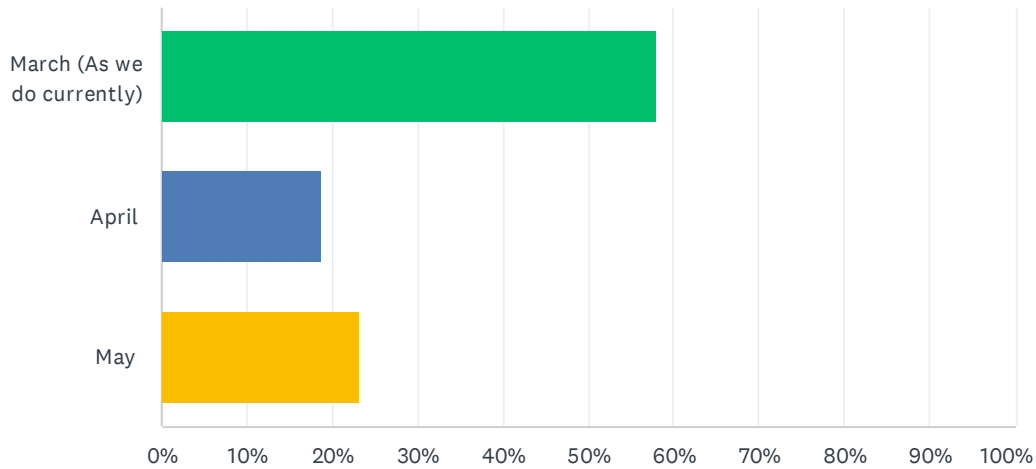

Q4 Would you prefer to hold elections for town offices in:(These are the three choices we are allowed under state law. A municipal election cannot be held in November unless the community is a city)

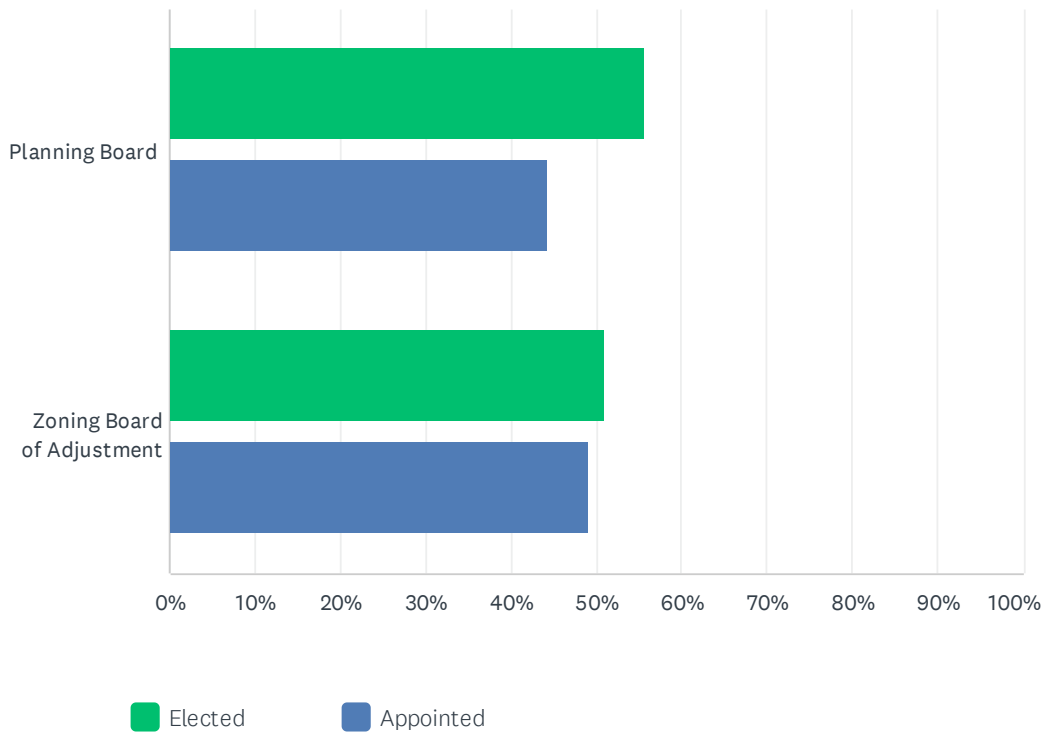

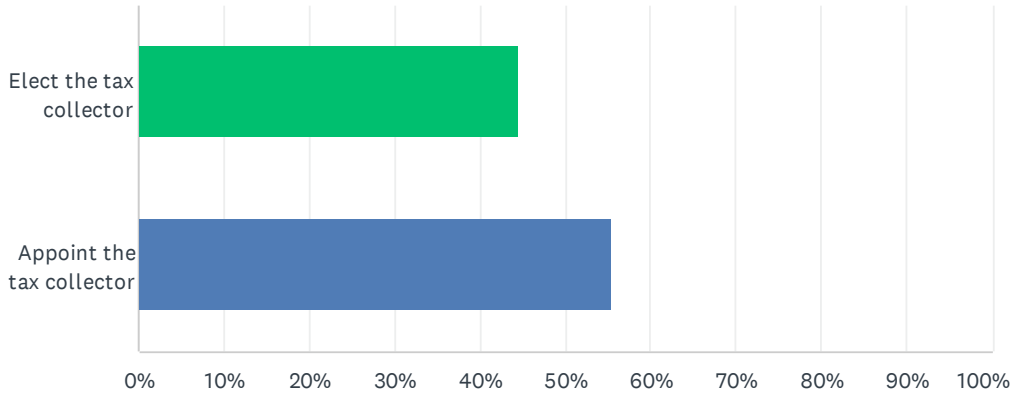

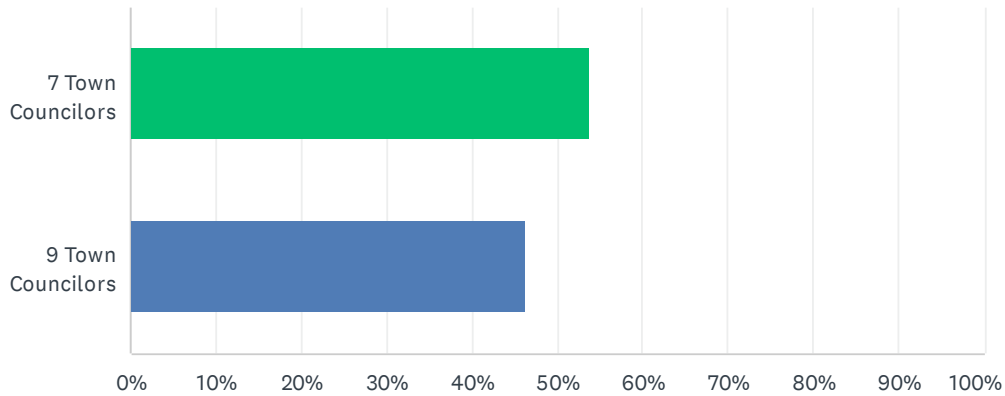

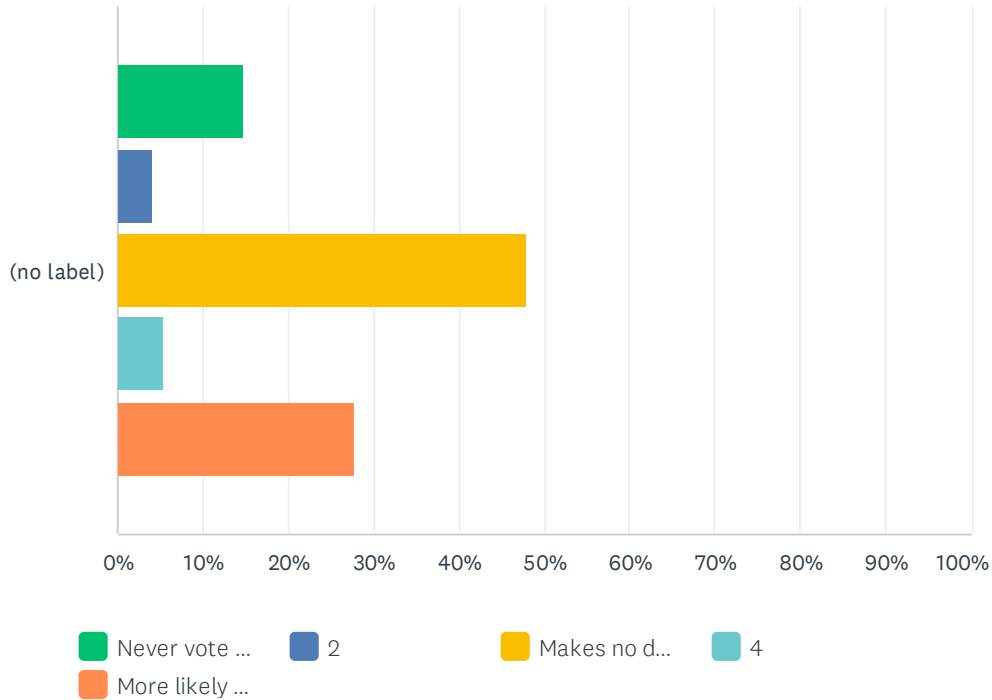

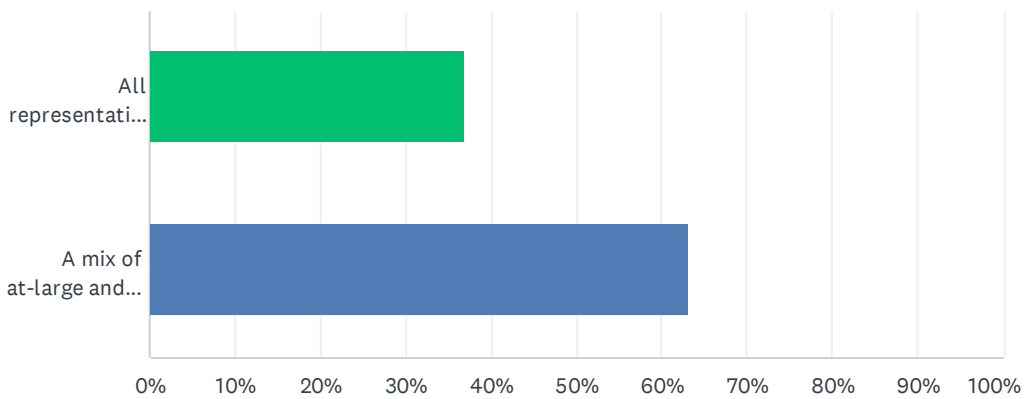
