INVITATION TO BID

Roadway Stabilization Program, Salem, NH

Sealed Bids for Roadway Stabilization Program will be received at the office of the Building Department, Town Hall, 33 Geremonty Drive, Salem, New Hampshire until **11am on January 29, 2014**, at which place and time said Bids will be publicly opened and read aloud.

The work includes approximately 23,500 linear feet of milling and overlay work on So. Broadway (Rte 28), Pelham Road, Lakeside St, Palmer St, Queen Anne Ln, Azarian Rd, St Mary's Ln, Cote Rd, Walnut Ter, Floral Ave, Harley Ln, Smith St, and Webster St in the Town of Salem, New Hampshire. The project also involves small quantities of road patching, gravel work, drainage work, and curbing/berm work.

Awarding of this project is contingent upon the appropriation of funding in March 2014.

Each bid shall be accompanied by a bid security in the form of a certified treasurer's or cashier's check or bid bond in the sum of five (5) percent of the Bid Price.

Contract Documents may be examined and obtained, in electronic format on CD, on or after **January 14, 2014** at the office of **Purchasing Agent, Town Hall, 33 Geremonty Drive, Salem New Hampshire 03079**. To obtain documents a \$25 non-refundable deposit is required. Cash will not be accepted. Successful bidder must furnish 100 percent Construction Performance Bond, 100 percent Construction Payment Bond and a \$25,000.00 Warranty Bond.

Substantial contract completion date shall be **August 01, 2014**.

Contract Final Completion date shall be **September 05, 2014**.

No bidder may withdraw his/her Bid for a period of 90 calendar days after the actual date of the opening of the Bids.

Complete instructions for filing Bids are included in the Instructions to Bidders.

An optional pre-bid conference will be held at Town Hall, 33 Geremonty Drive, Salem, New Hampshire, at **3 pm on January 21, 2014**. Representatives of the Owner will be present to discuss the Project. Owner will transmit to all prospective Bidders of record such Addenda, as Owner considers necessary in response to questions arising at the conference. Oral statements made at the pre-bid conference may not be relied upon and will not be binding or legally effective.

The Owner reserves the right to reject any or all Bids, should the Owner deem it to be in the public interest to do so.
