

## ADVERTISEMENT FOR BIDS

### Replacement of Bridge No. 095/175 Teague Drive over the Spicket River

Sealed Bids for the Replacement of Bridge No. 095/175 Teague Drive over the Spicket River will be received at the office of the Building Department, Town Hall (Upstairs), 33 Geremonty Drive, Salem, New Hampshire until 3:00 pm on **April 24, 2014**, at which place and time said Bids will be publicly opened and read aloud in the conference room on the main level. This project is located on Teague Drive between the intersections with Parker Circle and Pawtucket Lane in the Town of Salem for a total project length of 345 feet. The project consists of removal of two existing corrugated metal pipe arches which the Spicket River flows through being replaced with two 16 foot span box culverts with concrete wingwalls. Additional work includes approximately 100 feet of approach roadway reconstruction, 200 feet of pavement overlay, guardrail safety upgrades and slope stabilization.

Each bid shall be accompanied by a bid security in the form of a certified treasurer's or cashier's check or Bid Bond in the sum of five (5) percent of the Bid Price.

Successful bidder must furnish 100 percent Construction Performance Bond and 100 percent Construction Payment Bond as well as a two (2) year \$25,000 Warranty Bond.

The date of substantial contract completion shall be **September 12, 2014**. The date of contract Final Completion shall be **October 10, 2014**.

No bidder may withdraw their Bid for a period of 90 days, excluding Saturdays, Sundays, and legal holidays, after the actual date of the opening of the Bids. Bidders must be listed on the NHDOT "Prequalified Contractor's List" with a classification of bridge and or box culvert construction, or provide written documentation of prequalification from NHDOT as of the date and time of the Bid Opening. Bids submitted from bidders who are not on the NHDOT "Prequalified Contractor's List" or who cannot provide written proof of prequalification from NHDOT at the time of the bid opening will be deemed unresponsive and returned.

Complete instructions for filing Bids are included in the Instructions to Bidders.

An optional pre-bid conference will be held at Town Hall, 33 Geremonty Drive, Salem, New Hampshire, at 11:00 am on **April 15, 2014**. Representatives of the Owner will be present to discuss the Project. Owner will transmit to all prospective Bidders of record such Addenda, as Owner considers necessary in response to questions arising at the conference. Oral statements made at the pre-bid conference may not be relied upon and will not be binding or legally effective.

The Owner reserves the right to reject any or all Bids, should the Owner deem it to be in the public interest to do so.
