

ADVERTISEMENT FOR BIDS

Replacement of Bridge No. 118/116 Town Farm Road over the Spicket River

Sealed Bids for the Replacement of Bridge No. 118/116 Town Farm Road over the Spicket River will be received at the Building Department of the Town Hall (main level), 33 Geremonty Drive, Salem, New Hampshire until 3:00 pm on **July 30, 2015**, at which place and time said Bids will be publicly opened and read aloud in the Knightly Meeting Room on the lower level. This project is located on Town Farm Road and Bluff Street Extension between the intersections with Hawkins Glenn Drive and North Main Street in the Town of Salem. The project length is approximately 1200 feet. The project consists of removal of the existing 15'-0" span concrete and steel beam bridge which spans the Spicket River being replaced with a 42' long prestressed concrete deck beam bridge supported by reinforced concrete abutments and wingwalls. Additional work includes approximately 1155 feet of approach roadway reconstruction, guardrail safety upgrades and slope stabilization.

Each bid shall be accompanied by a bid security in the form of a certified treasurer's or cashier's check or Bid Bond in the sum of five (5) percent of the Bid Price.

Successful bidder must furnish 100 percent Construction Performance Bond and 100 percent Construction Payment Bond as well as a two (2) year \$50,000 Warranty Bond.

The date of substantial contract completion shall be **May 27, 2016**. The date of contract Final Completion shall be **June 24, 2016**. **A mandatory 105 day winter shutdown is included in the contract.**

No bidder may withdraw their Bid for a period of 90 days, excluding Saturdays, Sundays, and legal holidays, after the actual date of the opening of the Bids. Bidders must be listed on the NHDOT "Prequalified Contractor's List" with a classification of bridge construction, or provide written documentation of prequalification in bridge construction from NHDOT as of the date and time of the Bid Opening. Bids submitted from bidders who are not on the NHDOT "Prequalified Contractor's List" or who cannot provide written proof of prequalification from NHDOT at the time of the bid opening will be deemed unresponsive and returned.

Complete instructions for filing Bids are included in the Instructions to Bidders.

An optional pre-bid conference will be held at Town Hall, 33 Geremonty Drive, Salem, New Hampshire, at 11:00 am on **July 15, 2015**. Representatives of the Owner will be present to discuss the Project. Owner will transmit to all prospective Bidders of record such Addenda, as Owner considers necessary in response to questions arising at the conference. Oral statements made at the pre-bid conference may not be relied upon and will not be binding or legally effective.

The Owner reserves the right to reject any or all Bids, should the Owner deem it to be in the public interest to do so.
