

## NOTICE TO CONTRACTORS

### South Broadway and Lazarus Way Drainage Repair, Salem, NH BID 2016-007

Sealed Bids for the South Broadway and Lazarus Way Drainage Repair project will be received at the office of the Purchasing Agent, Town Hall, 33 Geremonty Drive, Salem, New Hampshire until **1 pm on April 26, 2016**, at which time said Bids will be publicly opened and read aloud in the Knightly meeting room on the lower level. Each bid must be submitted in a sealed envelope that is clearly marked: **South Broadway & Lazarus Way Drainage Repair Attention: Roy Sorenson, Director of Municipal Services.** Late Bids will not be considered.

This work includes replacement of a 4'x6' corrugated pipe arch drainage pipe with adjacent pavement restoration at #438 South Broadway in the Town of Salem, NH. The work has a bid alternate for the replacement of drain structures and pipe crossing with adjacent pavement and shoulder restoration on Lazarus Way in Salem, NH.

Each bid shall be accompanied by a bid security in the form of a certified treasurer's or cashier's check or bid bond in the sum of five (5) percent of the Bid Price.

Contract Documents may be examined and obtained, in electronic format on CD, on or after **April 6, 2016** at the office of **Purchasing Agent, Salem Town Hall, 33 Geremonty Drive, Salem, New Hampshire, 03079.** Documents may be examined, but not obtained, at the Engineering Department, Town Hall, 33 Geremonty Drive, Salem, NH 03079. To obtain Contract Documents, a \$25 non-refundable deposit is required. Cash will not be accepted.

Successful bidder must furnish 100 percent Construction Performance Bond, 100 percent Construction Payment Bond and a \$10,000.00 Warranty Bond.

The project is intended to begin July 2016. Project completion shall be within 90 days of the Notice to Proceed date.

No bidder may withdraw his/her Bid for a period of 90 calendar days after the actual date of the opening of the Bids.

Complete instructions for filing Bids are included in the General Terms and Conditions.

An optional pre-bid conference will be held at Town Hall, 33 Geremonty Drive, Salem, New Hampshire, at **3:00 pm on April 19, 2016.** Representatives of the Owner will be present to discuss the Project. Owner will transmit to all prospective Bidders of record such Addenda, as Owner considers necessary in response to questions arising at the conference. Oral statements made at the pre-bid conference may not be relied upon and will not be binding or legally effective.
