INVITATION TO BID

Roadway Improvement Project:
Haverhill Road and Klein Drive

Sealed Bids for the Roadway Improvement Project – Haverhill Road and Klein Drive will be received at the office of the Building Department, Town Hall, 33 Geremonty Drive, Salem, New Hampshire until **11:00am on January 18, 2017**, at which time said Bids will be publicly opened and read aloud in the Knightly meeting room on the lower level.

The work includes roadway reconstruction in the form of complete excavation of the roadway subbase, placing new subbase material, reshaping and repaving, drainage improvements and grading along approximately 2600 linear feet of Haverhill Road. Additional work includes the roadway reconstructions using pavement reclaim in place along Klein Drive from the intersection of Haverhill Road to the Town line for approximately 1350 linear feet in the Town of Salem, New Hampshire.

Each bid shall be accompanied by a bid security in the form of a certified treasurer's or cashier's check or bid bond in the sum of five (5) percent of the Bid Price.

Contract Documents may be obtained, in electronic format on CD, on or after **December 22, 2017** at the office of **Purchasing Agent, Salem Town Hall, 33 Geremonty Drive, Salem, New Hampshire, 03079 for a non –refundable deposit of \$50 (Cash will not be accepted).** Documents may be examined, but not obtained, at the Engineering Department, Town Hall, 33 Geremonty Drive, Salem, NH 03079, at Associated General Contractors, 48 Grandview Road Bow, NH 03304 or at Construction Summary of NH, Inc. 734 Chestnut Street, Manchester, NH, 03104.

Successful bidder must furnish 100 percent Construction Performance Bond, 100 percent Construction Payment Bond and a \$75,000.00 Warranty Bond.

Substantial contract completion time shall be **September 29, 2017.**

Contract Final Completion time shall be **October 27, 2017.**

Project is subject to Town appropriation of funding in March 2017.

No bidder may withdraw his/her Bid for a period of 90 calendar days after the actual date of the opening of the Bids.

Complete instructions for filing Bids are included in the Instructions to Bidders.

An optional pre-bid conference will be held at Town Hall, 33 Geremonty Drive, Salem, New Hampshire downstairs in the Knightly meeting room, at **2:30 pm on January 5, 2017.** Representatives of the Owner will be present to discuss the Project. Owner will transmit to all prospective Bidders of record such Addenda, as Owner considers necessary in response to questions arising at the conference. Oral statements made at the pre-bid conference may not be relied upon and will not be binding or legally effective.

The Owner reserves the right to reject any or all Bids, should the Owner deem it to be in the public interest to do so.
