

**ADVERTISEMENT FOR BIDS**  
**Town of Salem NH**  
**Southern NH Regional Water Project**

Separate sealed BIDS for the construction of the **Southern New Hampshire Regional Water Project – Shannon Road Area Water Main, Contract S3**, will be received at the office of the Purchasing Agent, Town Hall, 33 Geremonty Dr., Salem, New Hampshire, 03079, until **1:30 P.M. local time on Wednesday, June 26, 2019**. BIDS will then be publicly opened and read aloud in the Knightly Meeting Room at Town Hall. Project includes the installation of approximately 620 linear feet of 12-inch ductile iron water main, 3,250 linear feet of 12-inch PVCO water main, and 550 linear feet of HDPE water main installed via horizontal directional drill methods on Shannon Road and associated side streets, as well as valves, hydrants and other appurtenances.

1. Completion time for the project will be calculated as calendar days from the date specified in the “Notice to Proceed” as follows:  
170 calendar days for substantial completion.  
200 calendar days for final completion.  
Liquidated damages will be in the amount of \$800.00 for each calendar day of delay from the dates established for substantial completion and final completion.
2. Each General Bid shall be accompanied by a Bid Security in the amount of 5% of the Total Bid Price.
3. The successful Bidder must furnish 100% Performance and Payment Bonds, and will be required to execute the Contract Agreement within 10 days following notification of the acceptance of the Bid.
4. No Bidder may withdraw a Bid within 60 days after the actual date of opening thereof.
5. Any contract or contracts awarded under this Advertisement for Bids are expected to be funded in whole or in part by:
