1. Completion time for the project will be calculated as calendar days from the date specified in the "Notice to Proceed" as follows:

180 calendar days for substantial completion (by October 14, 2020).
210 calendar days for final completion (by November 13, 2020).

Liquidated damages will be in the amount of \$ 1,000 for each calendar day of delay from the date established for substantial completion, and \$ 400 for each calendar day of delay from the date established for final completion.

2. Each General Bid shall be accompanied by a Bid Security in the amount of 5% of the Total Bid Price.
3. The successful Bidder must furnish 100% Performance and Payment Bonds, and a \$75,000 Warranty Bond.
4. The contract awarded under this Advertisement for Bid is expected to be funded in whole or in part by a State Aid Grant from the NH Department of Environmental Services (SAG)
5. No Bidder may withdraw a Bid within 90 days after the actual date of opening thereof.
6. There will be a **non-mandatory pre-bid meeting** for all prospective bidders held at the **Salem Town Hall (33 Geremonty Drive) at 10:00 AM on January 16, 2020.**
