News and Noteworthy:

Salem Police Department Moving to Temporary Facility

Starting on Monday, April 7th, the Salem Police Department will commence a phased movement of all police operations to a temporary facility. The temporary facility is located at 21A Cross Street and will be co-located with the Town's Municipal Services Department - Department of Public Works. The department expects to have completely transferred operations to the temporary facility by Thursday, April 10th, at which point, our current location at 9 Veterans Memorial Parkway will be closed for eventual tear down. There will be signage directing people to the new location once the current location has closed.



There will be public access at the temporary facility for people wishing to file a report, request records, or for any other reason individuals visit the police department. This movement of operations to the temporary facility may cause a slight delay in the processing of records requests, however, all records requests will be answered. The Salem Police Department would encourage residents seeking to make a records request to use our online Records Request available on our department webpage, or through the following link:

Also on our webpage, or by using the same link above, you can file an online report. This is for incidents that are not an emergency or "in progress." By utilizing the online report, a citizen can file the details of the incident, along with other information that will be required for a report and will later be contacted by a police officer if further information is required. Salem merchants are strongly encouraged to utilize the online report system to report past shoplifting incidents.

The department plans on being at the temporary facility for between 16 and 18 months, with the expected move back to the new police facility at 9 Veterans Memorial Parkway taking place in the Fall of 2026.

First Responders Wellness Seminar

Second Annual SNHCISM Team's First Responder Wellness Summit focuses on equipping New Hampshire's First Responders with essential connections to manage stress and reactions to critical incidents will take place on May 21st and May 22nd. The Summit is hosted by the Salem NH, Police Department Wellness Team and provides training on decreasing stigma, normalizing stress responses, implementing strategies to minimize these effects, family support, lived experiences, suicide prevention, and identifying resources for seeking help when needed.

Mosquito Control Program Update - Spring 2025

The Mosquito Control Program will begin the week of April 7, 2025, in the Town of Salem. Crews from Dragon Mosquito Control, Inc. will be inspecting swamps, marshes, woodland pools, ditches, catch basins, storm drains, and other areas of shallow, stagnant water to identify mosquito larvae. If larvae are found, treatment may take place using one or more of the following insecticides:



At this time, there are no plans for emergency spraying for disease-carrying mosquitoes. Should the need for adult mosquito spraying arise, town officials will consult with Dragon Mosquito Control. The decision to spray on town and school-owned property will be based on mosquito surveillance data, disease test results, weather conditions, and other relevant factors. If emergency spraying becomes necessary, the public will be notified accordingly.

Residents who own wetlands and wish to opt out of any treatment can register through the No-Spray Registry on Dragon Mosquito Control's website at www.DragonMosquito.com/No-Spray-Registry, or by mailing a request to Dragon Mosquito Control, P.O. Box 46, Stratham, NH 03885. Please include your name, physical address, phone number, house color, and acreage.

Hydrant Flushing Program – Spring 2025

Salem's annual hydrant flushing program begins Thursday, April 11, 2025, and will continue weekly on Thursdays from 11:00 PM to 5:00 AM for several weeks. Visit the Utilities Division page for details.

Crews will inspect and maintain hydrants by checking for damage, lubricating parts, flushing under full flow, verifying proper drainage, and clearing vegetation. Any issues found will be logged, with repairs scheduled as needed. Hydrants that do not self-drain will be pumped out and rechecked to ensure they remain dry.



This program helps keep hydrants operational and contributes to Salem's favorable ISO fire insurance rating, benefiting property owners. Crews typically complete 25 to 35 hydrants per shift, taking about 4 to 6 weeks to finish the process. Challenges include hydrants blocked by fences or landscaping, high water flow requirements, traffic hazards, and occasional vandalism. Residents are encouraged to keep hydrants clear and drive cautiously in flushing areas.

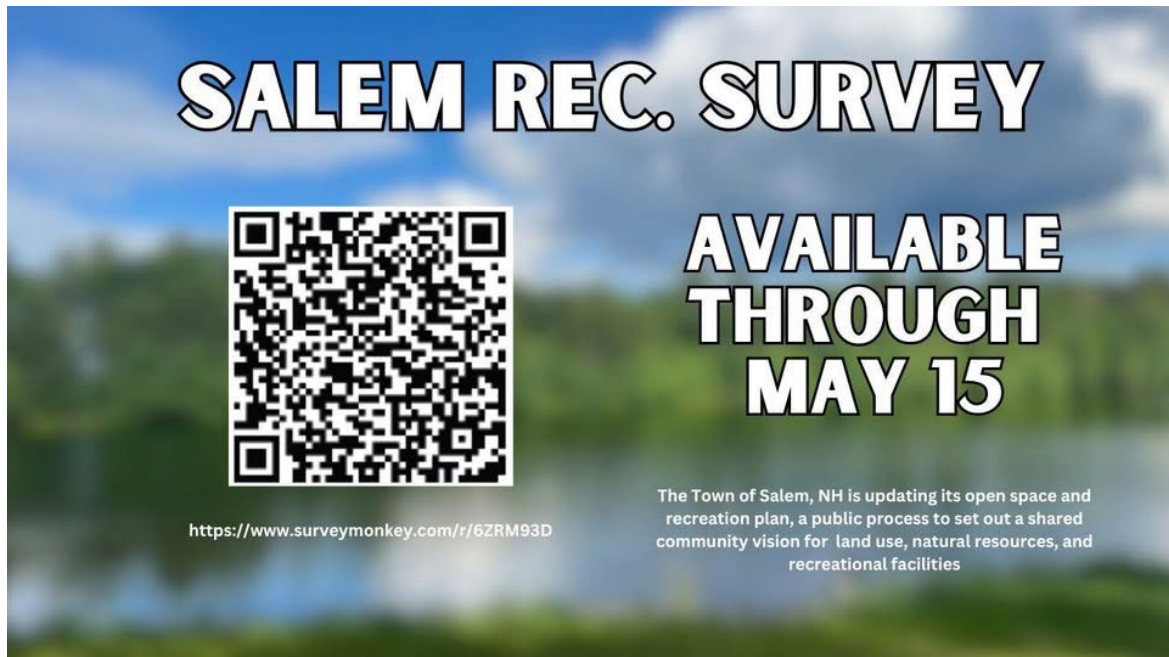


Shaping the Future of Recreation in Salem
