Lancaster Fund Request for Funding is Open

The Lancaster Fund is an endowment to the residents of the Town of Salem, NH administered by the Town Council with the stated purpose to be used to make Salem a better place to live. It is the philosophy of the Council that any and all disbursements from the fund impact positively the lives of all of its residents. While acknowledging this may not be possible with every disbursement, the Council shall determine which funding request provides the greatest benefit to the residents of Salem.



Each year in mid-April, the Town Council establishes a 30-day period for non-profit organizations to submit a request for funding from the Lancaster Fund. The highest amount an organization may receive is \$2,500. The Town Council has announced funding requests from the Lancaster Fund will be accepted between April 21, 2025 to May 21, 2025. The Salem, NH Town Council has issued a call for candidates to serve as the Town Clerk. The term will be until the next election in March 2026.

The Town Clerk is a vital and highly visible elected position in the Town of Salem. In accordance with New Hampshire law, the Town Clerk must be a resident of. The Town Clerk plays a central role in municipal operations, including the administration of elections, vital record keeping, motor vehicle registrations, and preservation of public documents.

Interested residents wishing to serve as the Town Clerk may submit a letter of interest and resume to the Town Council through the Town Manager's Office. The deadline for submitting a letter of interest is 5:00 p.m., Tuesday, May 13, 2025.
