**Resolution #2025-33**

**Withdraw \$6,279.54 from Pelham Road Improvement Trust Fund**

**WHEREAS:** Section 1.2 of the Town Charter vests in the Town Council the powers of the legislative and governing bodies; and

**WHEREAS:** The Pelham Road Improvement Trust Fund was established by Dr. Bart Quirinale on March 8, 1990 to assist in traffic and infrastructure improvements along the Pelham Road corridor; and

**WHEREAS:** A traffic improvement project through a fiber network expansion will improve signal timing and capacity at the Pelham Road/Stiles Road intersection, Rt 38/Stiles Rd intersection, and Rt38/S. Policy intersection; and

**WHEREAS:** The last account balance of the Pelham Road Improvement Trust Fund was \$6,279.54 and which account continues to accrue interest; and

**WHEREAS:** RSA 31:19 through 38-a establishes and regulates the conditions of trusts and authorizes the Governing Body to spend trust fund moneys; and

**WHEREAS:** The Pelham Road Improvement Trust Fund Authorizes the Town of Salem Board of Selectmen, now Town Council, to manage, expend, and contribute to the trust.

**NOW, THEREFORE, BE IT RESOLVED BY THE SALEM TOWN COUNCIL THAT:**

The Salem Town Council hereby authorizes \$6,279.54 plus any earned interest from the last account statement to be withdrawn from the Salem Pelham Road Trust fund to pay for traffic improvements along the Pelham Road corridor.




